



## Teacher Grant Application – 2023 GUIDELINES

### Grants are limited to schools in Oklahoma

The 4RKids Foundation is a non-profit organization whose purpose is to develop and improve educational, vocational, and social programs for children and adults with special needs. As part of our annual outreach program, we invite teachers (both mainstream and special education) in area schools to apply for classroom grants. In the past years we have awarded more than \$89,000 in grants to special education teachers.

Grants will be considered and awarded for the implementation of innovative ideas and programs. Grant funds will be used to purchase equipment or materials necessary to implement these ideas or programs. **Grants must benefit children with disabilities and benefit more than one student.** Grants generally range from \$250-\$1000.

**WHAT WE DO NOT FUND:** We do not fund requests for iPad or requests for annual fees and/or subscriptions. Most projects funded have items that can be reused for more than one year. The grant also cannot be used for items, programs, or equipment that would be provided under Title I funding. Grant funds cannot be used to pay for previously purchased items.

Applications are due no later than October 1st, 2023 at 4:30 p.m. in our office at 710 Overland Trail. Applications can be submitted by mail or e-mailed to [blangley@4rkids.com](mailto:blangley@4rkids.com).

Applications must be typed. Please do not use any covers or bindings for the application. If mailing or hand-delivering application, please staple in the upper left-hand corner.

Applications are reviewed by a sub-committee of the 4RKids Board of Directors. The committee evaluates the applications on a confidential basis, with all identifying names and information removed from the application. All decisions of the grant committee are final.

If a grant is awarded, 4RKids will purchase the items requested and contact the recipient to arrange pick-up or delivery. Out of town recipients, if awarded a grant, must make arrangements to pick up the items from our office in Enid, Oklahoma. Non-consumable items purchased with grant money become the property of the local school district.

Attach the order form for your item(s) or if there is no order form, attach an informational copy of the product(s) to be purchased, including price, shipping and place of purchase. Quotes from companies are beneficial. Please make sure there is NO identifying information on the order form.
